# AUTONOMOUS WEAPONS: AN INTRODUCTION

The term "autonomous weapon system" means any weapon system that has autonomy in the critical functions of selecting and attacking targets: in other words, force may be used without the involvement of a human decision maker.



Autonomy is a capability: autonomous weapons can take any physical form: flying drones, stationary weapons such as sentry guns, land-based vehicles such as tanks, as well as boats and submarines. Automated target recognition and automatic target engagement features are now to be found in a variety of weapons being produced by a number of manufacturers.

Autonomy in weapons systems is not completely new. However, previous generations of weapons systems which incorporated autonomy tended to operate in a fixed location where human operators were present (for example, C-RAMs - counter rocket, artillery, and mortar systems). Physical presence meant that operators had high awareness of the surrounding environment, as well as the ability to physically turn off the weapon if necessary. Target profiles for such systems were restricted to military targets, such as incoming missiles.

The emerging new generation of autonomous weapons is different. Weapons are independently mobile, and are designed to operate against a broader variety of targets, including human beings and other non-exclusively military objects. These weapons are systems of much higher complexity than previous generations of autonomous weapons systems (such as C-RAMs). The fact that weapons are mobile means that the variety they may encounter in the environment is much greater than fixed systems. These factors mean a much higher potential for such weapons to display unpredictable behaviour.

A number of concerns arise in relation to autonomous weapons, including:

- Can military commanders (or weapons manufacturers) be held accountable for unlawful acts carried out by autonomous weapons?
- Is the use of force without human control consistent with the public conscience? In polls, a majority say it is morally unacceptable.
- Does proliferation of autonomous weapons pose a threat to stability?

The Campaign to Stop Killer Robots has called for new international law to address the problems that increasing autonomy poses. The first element of a new international law is an obligation to maintain meaningful human control over the use of force ('meaningless' human control is also possible, for instance if the human operator does not have sufficient time to make a decision). The Campaign also calls for an explicit ban on autonomous weapons systems that target human beings, as well as any weapon that cannot be meaningfully controlled (e.g. where the behaviour of the system is unpredictable).
